OPERATING PROCEDURE CHANGE

At the January Board Meeting the Board approved a motion to change the Operating Procedures pertaining to trip cancellations. Trip coordinators want to minimize the risk of the Club losing money on nonrefundable payments they make for event tickets when a member cancels. This is true also for hotel charges (for any unused rooms due to cancellation). The change requires Trip Coordinators to include an advisement on trip flyers when a trip requires purchase of nonrefundable tickets. The advisement must say that by a date certain, there will be no refunds to members of those nonrefundable expenses if they cancel the trip.*

The motion was approved and the amended Operating Procedures will be on the website soon. Meanwhile, the new trip flyers that have the advisement will be like the one on the Tina Turner Musical flyer within this Newsletter.

*The exceptions already in the Operating Procedures re a doctor's note or death in the immediate family will still be accepted exceptions when approved by the Board.

The **other** Operating Procedure that was changed is the wording about trip buses having lavatories. The Trip Coordinators would sometimes like to take fewer members on a smaller bus (rather than cancel trips for lack of sign-ups and to also get in some places large buses can't) and the smaller buses do not have lavatories. However, all itineraries for all buses do stop at rest stops very often. New wording on the Operating Procedures says lavatories will be required on the full sized buses. PLEASE NOTE: IF A TRIP WILL BE ON A SMALLER BUS, IT WILL BE NOTED ON THE FLYER.

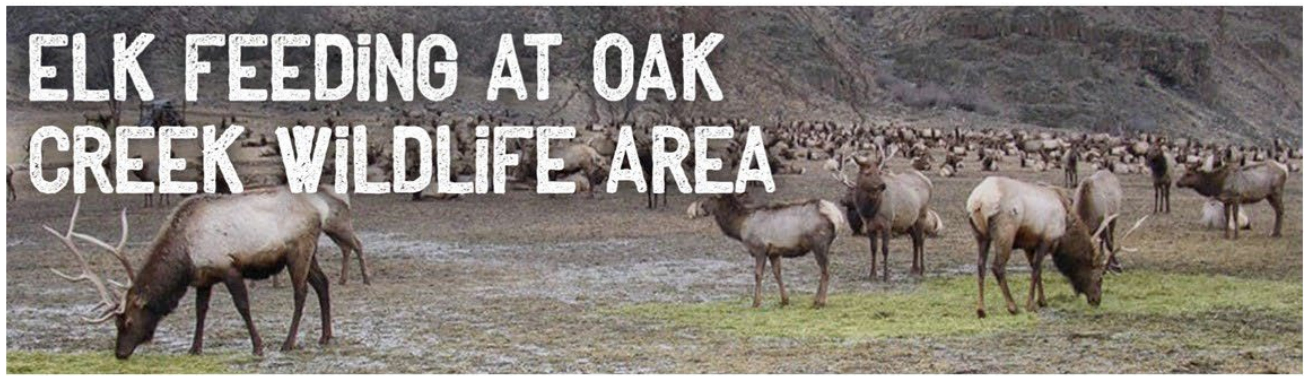

When snow blankets the mountains, the elk are forced to migrate to the foothills to find food. 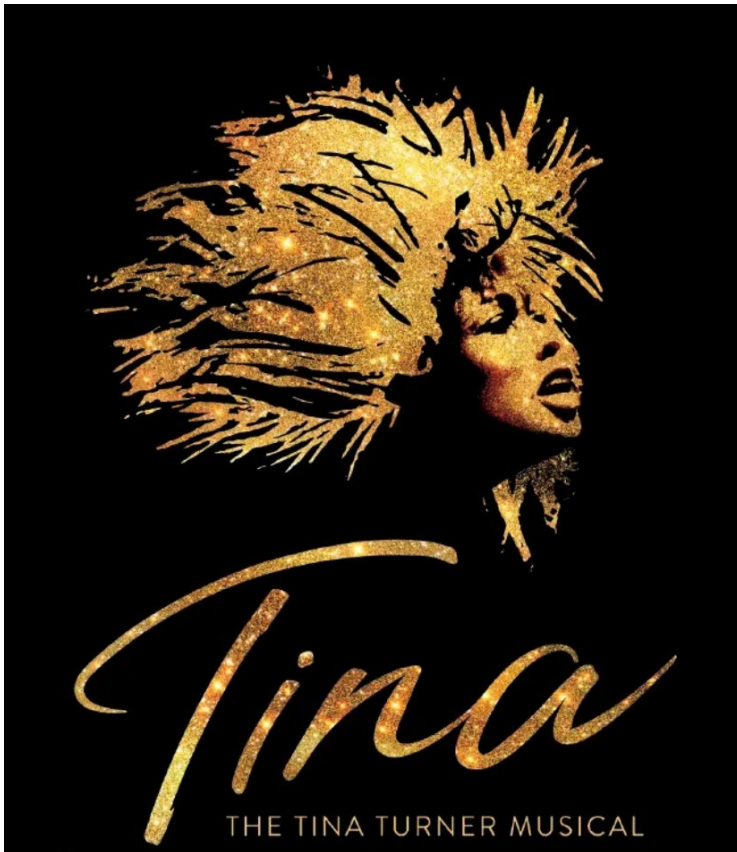

Check Your Medicare and Supplemental Health Insurance Summaries, PLEASE

A New Year has started and maybe you've already broken some of your New Year's Resolutions. Dortha Backer and I would like to encourage each Rambling Rover to adopt the following New Year's Resolution which is easy keep: Each time you receive a MEDICARE SUMMARY NOTICE FOR Part B (Medical Insurance) or your supplemental insurance summary statement please take the time to make sure that the charges listed are really YOUR charges and not a scam.

I know sometimes it is hard to figure out if they are really your charges when you went some place locally and the address given is not a local address. But did you really travel to Florida one day a month for six months for "gel wound care" at \$2,022.72 per visit? Check and see if these claims are actually being charged to your CURRENT Medicare Number. There was one number different in my Medicare number they were charging these scam charges to. I'm pretty sure I would have remembered traveling to Florida for a total of ten months for medical appointments at Sunshine Senior Solutions in Del Ray Beach, FL, but I've never been to Florida in my entire life. After submitting six claims for "gel wound care" for a total of \$12,136.32, this outfit submitted four more claims for "300 intermittent urinary catheter with insertion supplies" at \$2,116.80 each month. That comes to a total of \$20,603.52 that they are trying to collect. Dortha's fraud charges are more than double what my scam claims amount to—over \$50,000! This is your tax money and my tax money they are claiming they are owed. WE pay enough in taxes without supporting these scammers.

If you do find claims on your statements that are not yours, call the Fraud Hotline number 1-800- MEDICARE (1-800-633-4227) and say you want to report a Fraud claim on your statement and tell them to BE SURE AND FORWARD YOUR INFORMATION TO THE FRAUD DEPARTMENT. Sometimes they took all my information and still did not forward it to the Fraud Department. Notify your supplemental health insurance company as well. I also contacted HEALTH AND HUMAN SERVICES OFFICE OF INSPECTOR GENERAL 1-800-447-8477 and asked to speak directly to the FRAUD DEPARTMENT. The people you talk to at these numbers are very nice

Please DO NOT just toss your summary notices in the trash without first looking at them to determine if the charges listed are really services you received. Thank You.
